## **Consequences of Cancellation**

If you revoke this contract, we will refund all payments received from you, including delivery costs but excluding any additional costs arising from any delivery method chosen by you that differs from our standard economy delivery. This refund will take place without delay or within 14 days of the receipt by us of your notification of revocation of this contract.
